- b) The candidates should report their original certificates and Demand Draft or UTR Number for Electronic Fund Transfer through NEFT / RTGS for prescribed tuition fee & other fees as specified herein below.

4). IMPORTANT NOTE:

a)	Candidates are instructed to visit the MCC of DGHS (Directorate General of Health Services), Ministry of Health & Family Welfare, Govt. of India, New Delhi website: www.mcc.nic.in and College website: www.vmmckkl.edu.in from time to time.
b)	Provisional Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the NMC and medical fitness of the candidates. Those who do not fulfill the prescribed eligibility criteria and medical fitness will not be admitted to the course of study to which they are allotted by the MCC of DGHS. If it is found at a later stage that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.
c)	Students will be governed by all the University rules including refund of fees, hostel rules, disciplinary rules and UGC / NMC Regulations for Curbing the Menace of Ragging etc.

5). REFUND POLICY:
