- b) The candidates should report their original certificates and Demand Draft or UTR Number for Electronic Fund Transfer through NEFT / RTGS for the prescribed Tuition fee and other fees as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Dental College.
 - ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that "their original certificates are deposited with Institute / College / University" shall **not** be allowed to take admission in the allotted Dental College.
- d) Every student shall pay the tuition fee and other fees, as prescribed by the University, within the due date notified.
- e) Part payment of tuition fee and other fees are not permitted.
- f) No extension of time either for payment of fees or submission of original certificates will be entertained under any circumstances.
- g) At the time of admission, candidates and their parent / guardian should have to sign declaration form / undertakings in Annexure declaring that they shall abide by the rules and regulations of the University including Anti-Ragging regulations of the UGC / DCI and observe the good conduct & behavior and that they are bound by the University rules on payment of fees / refund of fees.

3) MODE OF PAYMENT OF FEES:

a) TUITION FEE & OTHER FEES:
