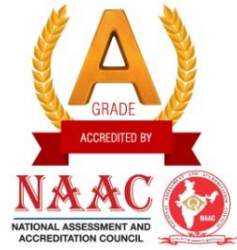

- b) The candidates should report their original certificates and Demand Draft or UTR Number for Electronic Fund Transfer through RTGS / NEFT for the Prescribed tuition fee and other fees as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Medical College.
- ii) Candidates who have deposited their original documents with any other Institute / College /University and come for admission with a certificate stating that “their original certificates are deposited with Institute / College / University” shall **not** be allowed to take admission in the allotted Medical College.
- d) Every student shall pay the tuition fee and other fees, as prescribed by the University, within the due date notified.
- e) Part payment of tuition fee and other fees are not permitted.
- f) No extension of time either for payment of fees or submission of original certificates will be entertained under any circumstances.

4) IMPORTANT NOTE:

- a) Candidates are instructed to visit the **MCC of DGHS** (Directorate General of Health Services), Ministry of Health and Family welfare, Govt. of India, New Delhi **Website: www.mcc.nic.in** and College website: **www.avmc.edu.in** from time to time.
- b) **Provisional Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the NMC and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and medical fitness will not be admitted to the course of study to which they are allotted by the **MCC of DGHS**. If it is found at a later stage, that

the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.

- c) Students will be governed by all the University rules including refund of fees, hostel rules, disciplinary rules and UGC / NMC Regulation for curbing the Menace of Ragging etc.
- d) All the disputes / arbitration arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University), Salem and Vice-Chancellor's decision shall be final and binding.
