- b) The candidates should report along with **original certificates and Demand Draft** for the prescribed tuition fee and other fees or UTR Number for **Electronic Fund Transfer through RTGS / NEFT** as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Medical College.

04) IMPORTANT NOTE:

- Candidates are advised to check the website of the **MCC of DGHS** (Directorate General of Health Services), Ministry of Health and Family Welfare, Govt. of India, New Delhi website: www.mcc.nic.in and College website: www.vmkvmc.edu.in from time to time.
- Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the NMC and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the MCC of DGHS. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- Students will be governed by all the University rules including rules for refund of fee, disciplinary rules, hostel rules and UGC /NMC Regulations for Curbing the Menace of Ragging etc .,
