## 2) GENERAL INSTRUCTIONS:

- a) Candidates who have been allotted through centralized counseling by the **MCC of DGHS**, MHFW, Govt. of India, New Delhi for admission to **BDS Degree Programme** in the Deemed to be University for the academic year 2025–2026, are advised to report and complete the admission process strictly within the date and time specified in the “**Provisional Allotment Letter**” issued by the **MCC of DGHS**.

- b) The candidates should report their **original certificates and Demand Draft** or UTR Number for **Electronic Fund Transfer through NEFT / RTGS** for the prescribed Tuition fee and other fees as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Dental College.
- ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that “their original certificates are deposited with Institute / College / University” shall **not** be allowed to take admission in the allotted Dental College.
- d) Every student shall pay the tuition fee and other fees as prescribed by the University within the due date notified.
- e) Part payment of tuition fee and other fees are not permitted.
- f) No extension of time will be given for the payment of fees or the submission of original certificates under any circumstances.
- g) At the time of admission, candidates and their parents / guardian should have to sign the declaration form / undertakings in Annexure declaring that they shall abide by the rules and regulations of the University including Anti-Ragging regulations of the **UGC / DCI** and observe the good conduct & behavior and that they are bound by the University rules on payment of fees / refund of fees.

### 3) MODE OF PAYMENT OF FEES:

#### a) TUITION FEE & OTHER FEES:

It is mandatory that the candidates should bring the prescribed tuition fee and other fees in the form of Demand Draft drawn in favour of **“Vinayaka Mission’s Sankarachariyar Dental College”** payable at Salem or remitted through NEFT / RTGS as mentioned in the Fees details.

### 4) IMPORTANT NOTE:

- Candidates are instructed to frequently visit the **MCC of DGHS** (Directorate General of Health Services), Ministry of Health and Family Welfare, Government of India, New Delhi **website: [www.mcc.nic.in](http://www.mcc.nic.in)** and **College website: [www.vmsdcsalem.com](http://www.vmsdcsalem.com)** for updates from time to time.
- The Provisional Allotment letter issued by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the Dental Council of India, New Delhi and Medical Fitness of the candidate. Those who**

do not fulfill the prescribed eligibility criteria and medical fitness will not be admitted to the above programme of study, which they are allotted by the **MCC of DGHS**. If it is found at a later stage that a candidate has given false information, forged / Fake certificates or concealed any material information, his / her admission will be cancelled without any notice.

- c) Students will be governed by all the University rules including refund of fees, disciplinary rules, hostel rules and **UGC / DCI** Regulations for Curbing the Menace of Ragging etc.
- d) Any disputes / arbitration arising regarding the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University), Salem and the Vice-Chancellor's decision shall be final and binding.

#### 5) REFUND POLICY:

We are aware and agree that, the following refund policy shall be strictly implemented by the constituent colleges of Vinayaka Mission's Research Foundation (Deemed to be University), Salem, Tamilnadu.

a.	Amount of Fee to be deducted from the candidate is upgraded by the MCC of DGHS.	An amount of Rs.25,000/- will be deducted.
b.	If the seat is surrendered to the MCC of DGHS in their Counseling portal within the stipulated timelines and the guidelines specified by the MCC of DGHS.	
c.	In all cases not covered under condition in column above, the amount of fee payable. (where the seat is rendered vacant without having any chance of being filled up with any other candidates)	The Entire fees paid by the candidate shall be forfeited. In addition, the candidates shall be required to pay the 'entire programme fees' for the remaining years of the programme period. (Except those who produce an upgradation letter issued by the MCC of DGHS)

Please note that the University will strictly follow the MCC of DGHS timelines / guidelines w.r.t. resignation procedures. All the candidates are advised to refer the Counseling Bulletin / Circulars uploaded by the MCC of DGHS for the updates on resignation timelines and applicable procedures for them.

- 5 12<sup>th</sup> Pass Certificate (in case of CBSE (or) ISCE)
