- The candidates should report their **original certificates and Demand Draft** or UTR) Number for **Electronic Fund Transfer through NEFT / RTGS** for the prescribed Tuition fee and other fees as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Dental College.

- b) **Provisional Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the Dental Council of India, New Delhi and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and medical fitness will not be admitted to the above Programmes of study to which they are allotted by the **MCC of DGHS**. If it is found at a later stage that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including refund of fee, disciplinary & hostel rules, UGC / DCI Regulations for Curbing the Menace of Ragging etc.
