- c) i) Candidates without original certificates / documents shall not be allowed to take admission in the allotted Medical College.
  - ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that "their original certificates are deposited with the Institute / College / University" shall **not** be allowed to take admission in the allotted Medical College.
- d) Every student shall pay the Tuition Fee and Other Fees, as per the schedule prescribed by the University within the due date notified.
- e) Part payment of tuition fee and other fees are not permitted.
- f) No extension of time will be given for the payment of fees (or) the submission of original certificates under any circumstances.
