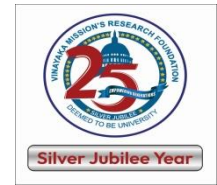
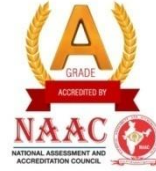

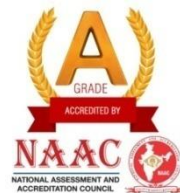
Dear Candidates,

## 2) ELIGIBILITY CRITERIA:

- a) Candidates passed the 10+2 /H.Sc. examination (or) its equivalent with Physics, Chemistry, Biology (Botany & Zoology) / Biotechnology, and English as individual subject and obtained a minimum of 50% aggregate marks in Physics, Chemistry and Biology in the qualifying examination for the **General Category**.

For candidates belonging to the OBC / SC / ST / Categories, a minimum of 40% aggregate marks in the above subjects.

In the case of Persons with Disabilities (PWD), the minimum required marks shall be 45% for the General Category and 40% for OBC/SC/ ST Categories.

- b) In addition, candidates must have obtained a minimum of 50<sup>th</sup> Percentile in NEET UG-2025 for the General Category and 40<sup>th</sup> Percentile for candidates belonging to OBC/SC / ST Categories. For candidates with Benchmark disabilities (PWD), the minimum required is 45<sup>th</sup> Percentile for the General Category and 40<sup>th</sup> Percentile for OBC /SC / ST Categories.
- c) Candidates should have completed 17 years of age on or before 31<sup>st</sup> December of the year of admission.

**6. IMPORTANT NOTE:**

- a) Candidates are instructed to frequently visit the **AACCC** (AYUSH Admissions Central Counseling Committee) of Ministry of AYUSH, Government of India, New Delhi **website: [www.aaccc.gov.in](http://www.aaccc.gov.in) and College website: [www.vmhmc.edu.in](http://www.vmhmc.edu.in)** for updates from time to time.
- b) **The Provisional Allotment letter issued by the AACCC of Ministry of AYUSH for admission is subject to fulfillment of all the eligibility criteria prescribed by the National Commission for Homoeopathy and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and medical fitness will not be admitted to the programme of study which they are allotted by the **AACCC of Ministry of AYUSH**. If it is found at a later stage that a candidate has given the false information, forged / fake certificates or concealed any material information, his/her admission will be cancelled without notice.

- c) Students will be governed by the University rules for refund of fees, disciplinary procedures, hostel rules and UGC/NCH Regulations for Curbing the Menace of Ragging etc.
- d) Any disputes/arbitration arising regarding the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University), Salem and Vice-Chancellor's decision shall be final and binding.

## 7. REFUND POLICY:

We are aware and agree that the following refund policy shall be strictly implemented by the constituent colleges of Vinayaka Mission's Research Foundation (Deemed to be University), Salem, Tamil Nadu.
