### 2) ELIGIBILITY CRITERIA:

- Candidates must have passed in H.Sc. (or) its equivalent examination with Physics, Chemistry, Biology (Botany & Zoology) and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination mentioned above for General Category and 40% marks in respect of the candidates belonging to SC / ST / OBC Category.
- In addition that, the candidates must have come in the merit list of NEET UG-2022, for obtaining the minimum eligible marks at 50<sup>th</sup> Percentile Score for General Category, 40<sup>th</sup> Percentile Score in respect of the candidates belonging to SC / ST / OBC and 45<sup>th</sup> Percentile Score in PWD (Persons with Disabilities) candidates.
- Candidates should have completed the age of 17 years on or before 31<sup>st</sup> December of the year of admission.

#### 4) GENERAL INSTRUCTIONS:

- a) Candidates who allotted through centralized counseling by the **AACCC of Ministry of AYUSH**, Govt. of India, New Delhi for admission to **BHMS Degree Programme** in the Deemed to be University for the academic year 2022-23, are advised to report and complete the admission process strictly within the date and time specified in the "Allotment Letter" issued by the **AACCC of Ministry of AYUSH**.

- b) The candidates should report along with **original certificates and Demand Draft NEFT / RTGS** or UTR Number for **Electronic Fund Transfer through / NEFT / RTGS** for the prescribed tuition fee and other fee as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Homoeopathy Medical College.
- ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that "their original certificates are deposited with Institute / College / University" shall **not** be allowed to take admission in the allotted Homoeopathy Medical College.
- d) Every student shall pay the tuition fee and other fee, as prescribed by the University, within the due date notified.
- e) Part payment of tuition fee and other fee are not permitted.
- f) No extension of time either for payment of fee or submission of original certificates will be entertained under any circumstances.

- g) At the time of admission, candidates should sign declaration / undertaking declaring that they shall abide by the rules and regulations of the University including Anti-Ragging regulations of the UGC / NCH and observe good conduct and behavior and that they are bound by the University rules on payment of fee / refund of fee.

- b) **Allotment letter given by the AACCC of Ministry of AYUSH for admission is subject to fulfillment of all the eligibility criteria prescribed by the NCH and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by **the AACCC of Ministry of AYUSH**. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including rules for refund of fee, disciplinary rules and hostel rules and UGC/NCH Regulations for Curbing the Menace of Ragging etc.,
- d) All the disputes / arbitration arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University) and Vice-Chancellor's decision shall be final and binding.
