#### Instructions to the Candidates

- III. The fees should be paid by the students through online payment on or before the stipulated time.
- IV. Students on roll have to pay the examination fee by online payment mode through Mycamu by individual login. Students have to download mycamu app from playstore and register by getting PIN from college for the online payment student's email and contact number to be utilized and this can be updated by the students themselves in Mycamu. After entering it must be approved by the admission section of the respective college to enable the students to make payment online through paytm.
