1. COURSES OFFERED :

Vinayaka Mission's School of Economics and Public Policy, Paiyanoor, Chennai **B.Sc. Economics - Hons. with Research Programme**

2. Duration of Programmes : 4 Years

3. Upper Age limit : (As on 1st July 2024)

Candidates should not exceed 21 years as on 1st July of year of admission; however a relaxation of 5 year is permitted for differently abled candidates. SC/ST / OBC and women candidates may be allowed the age relaxation of 3 year beyond 21 years for admission.

4. Eligibility:

A pass in 10 + 2 / H.Sc or its equivalent examination in first attempt with aggregate marks of 60% for General Category, 55% for OBC and 50% for SC/ST/PWD Category.
