### 1. PROGRAMME OFFERED:

### 2. ELIGIBILITY:

Programme	Eligibility
<b>Post Basic B.Sc. (Nursing)</b>	A Pass in Diploma in Nursing (or) its equivalent examination with 2 years Nursing service in any recognized Educational Institution / Hospital as full time Public Health Nurse after permanent Nursing registration in any State Nursing Council.

### 3. ONLINE FILLING OF APPLICATION FORM:

- Application forms are available online mode only. It should be filled up carefully by the candidates with complete details and submitted online along with scanned copy of Diploma certificate, Mark Sheet(s), Photograph & Signature as attachments.
- Information provided by the candidates in their online application form, like Name of the Candidate, Details of Parent / Guardian, Date of Birth, Gender, Educational Qualification, Community / Category Address and conduct details etc. will be treated as final and self-certified. The information is non-editable after the submission of application. Any request for change in these particulars will not be considered by VMRF(DU). Hence, ensure all the information entered in the application is true and correct before submission.
- During the online registration, all the candidates, should upload the Diploma Certificate, Mark Sheet(s) and necessary other documents on or before 20.06.2025.

- d) All the admission related communications like Rank and Counseling Intimation letter etc., will be sent through Application Portal only. Hence, the candidates are advised to keep their application number for their future reference. No separate communication will be sent to any individual E-mail (or) SMS.
- e) Incomplete online application form will not be accepted.

#### **4. ELIGIBILITY FOR COUNSELING:**

The following candidates are eligible to apply for the Counseling conducted by VMRF(DU)

Candidate desiring to join the two years programme leading to the Post basic B.Sc. (Nursing) Degree programme should have qualified for the Diploma in Nursing from an institution approved by the Nursing Council of India, New Delhi

#### **5. ELIGIBILITY CERTIFICATE:**

Candidates who have passed qualifying examination other than VMRF(DU), Salem should obtain Eligibility Certificate from Vinayaka Mission's Research Foundation (Deemed to be University), Salem and produce the same at the time of admission.

#### **6. COUNSELING CALL LETTER:**

- a) Counseling Call Letter can be downloaded by all the eligible candidates from the Application Portal of this University from 23.06.2025 onwards.
- b) Counseling call letter must be produced at the time of Counseling without fail. No candidate shall be allowed to attend the counseling without the call letter.
- c) Mere acceptance of a person as a candidate for counseling shall not confer on him / her any right /eligibility for admission. The name of the candidate who does not satisfy the prescribed eligibility criteria shall not be considered for admission.

#### **7. COUNSELING CENTRE:**

The Counseling will be conducted at **Vinayaka Mission's Research Foundation (Deemed to be University), Ariyanoor, Salem - 636 308.**

## **8. MODE OF SELECTION:**

- a) Admission made on the basis of marks obtained in the qualifying examination and merit based Counseling will be conducted by the Admission Monitoring Committee (AMC) of VMRF(DU) and eligibility criteria prescribed by the Indian Nursing Council, New Delhi and VMRF(DU) rules & regulations.

## **10. ANTI-RAGGING MEASURES:**

Ragging is strictly prohibited in Vinayaka Mission's Research Foundation (Deemed to be University) campuses strictly enforces anti-ragging measures and the campus is free from any form of ragging. Any violation of ragging will be dealt with according to law in force and as per the directions of the Hon'ble Supreme Court of India, UGC, Indian Nursing Council, New Delhi and VMRF (Deemed to be University), Salem.

## **11. RULES ON DISCONTINUANCE FROM PROGRAMME OF STUDY**

- a) In the event of discontinuation of Course, due to any reason, after the cut-off date prescribed by the statutory authorities / university for admission to the first year of the course concerned (or) where the seat is rendered vacant without having any chance of being filled up with any other candidate, student have to pay the applicable tuition fee and other fees as per the university regulations.
- b) All students and parent will be required to furnish a written declaration agreeing to the above said conditions at the time of admission.

## **12. IMPORTANT NOTE:**

- a) All admissions are subject to fulfillment of all the prescribed eligibility conditions by the candidate. If it is found either at the time of admission (or) at a later stage, that the candidate has given false information/forged certificates (or) concealed material information, his/her admission shall be cancelled and the student shall be dismissed from the college immediately.
- b) The Fee refund policy / timeline is followed as per the UGC guidelines.
- c) The VMRF (Deemed to be University) reserves the all right to change the curriculum, course structure, rules and regulations relating to admission, examinations, fee structure, refund, etc.
- d) Students will be governed by the University rules including refund of fee, disciplinary rules and hostel rules.
- e) All the disputes / arbitration arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University), Salem and Vice-Chancellor's decision shall be final and binding.
